Directions issued to Authorized Dealers on Payments for Imports made on Advance Payment (Cash-in-Advance) Terms

In terms of Section 9 (1) of the Foreign Exchange Act, No. 12 of 2017 (the Act), Authorized Dealers are hereby informed that with effect from 10 October 2018, Authorized Dealers are not permitted to release foreign exchange which involves conversion of Sri Lanka Rupees for making payments for the importation of non-essential consumer goods as specified in Annex I under the advance payment (Cash-in-Advance) terms.

2. Authorized Dealers should apprise customers (i.e., importers of goods) on this requirement and are required to comply with this direction until further notice.
